## A QuickGuide to Disaster Workforce Planning during the 2020 Hurricane-Coronavirus Pandemic Season and Beyond



This Quick Guide was developed with support from <u>USF Pandemic Response Research Network</u> and the <u>CONVERGE Network</u> to assist planners in recruiting and developing a disaster response workforce. Its contents were derived from review of the literature, existing guidance documents, and a series of working group calls with experts from diverse sectors.

### **Key Considerations**

- State, city, and county planners are trained to staff shelters under normal conditions, but not for sheltering under hurricane-pandemic conditions.
- Many disaster/emergency response workers have been activated for an extended period in 2020, increasing the risk of burnout, illness, or absenteeism.
- More shelters are needed, more staff and volunteers are needed to staff the shelters, while also minimizing on-site personnel to accommodate capacity restrictions
- Specialized training is needed for staff and volunteers. COVID-19-specific training and cross-training for multiple roles is essential.
- Key questions and issues remain regarding non-congregate shelter needs and staffing.
- Additional resources are needed to communicate with evacuees, protect staff and evacuees, meet demands of special-needs populations, and ensure the well-being of staff and evacuees

#### **Workforce/Staffing Capacity**

- Planners should assess community needs and capacities in terms of populations, facilities, supplies, and human resources (workforce).
- It is helpful to identify and to categorize worker roles by COVID-19/disaster risk and skill levels

#### Other considerations include:

- Staffing/scheduling models Consider shorter shifts, two staff per shift, breaks between shifts, needs of workers balancing home responsibilities (e.g. child care).
- Deployment Pre-plan deployment schedules, prepare workforce prior to deployment.
- Housing Workers may need separate housing, shelter managers need quiet, protected space.
- Ancillary support Virtual/telephone support, supervision, and consultation may be arranged.
- Training Consider offering all trainings, including just-in-time trainings to all workers.
