The widespread discrimination shows how urgently broad legislation that addresses cyberbullying, defends women's rights, and promotes a safer online environment is needed.

#### Social science

Psychological research on cyberbullying against women in Iraq explores how women's mental health are affected by cyberbullying. This study "License Discrimination and Cyberbullying against Women in Iraq" looks at how women's relationships and general well-being are impacted by cyberbullying, as well as how they handle or reject this kind of abuse. Psychologists also investigated the psychological mechanisms and motivations which underlie cyberbullying behavior on an individual and societal level.

#### Method/Data

The method for this study that was used was a qualitative research design, incorporating interpretivism philosophy and an inductive approach, to delve into the perceptions of cyberbullying among 9 women in Iraq. By employing purposive sampling, the research ensures selection of participants capable of providing detailed insights without gender bias. Focusing solely on women allows for a concentrated examination of their experiences, offering nuanced understanding and potentially revealing unique challenges they face in navigating cyberbullying.

The data was broken up into three categories: "Theme I: Prevalence of Discrimination", "Theme II: Social media Impact on Cyber security" and "Theme III: Organizations Working against Discrimination and Cyberbullying". Theme I was based off of the respondents personal experience with discrimination. According to *Open Access* "Eight Out of the 9.respondents in the study have Experience discrimination. In their personal or professional life. (Ali et al, 2023, p.102). In Theme II Researchers conducted six out of the nine respondents "... believed Internet education can effectively Cyber bullying." (Ali et al, 2023, p.103). In Theme III all of the respondents agreed that they haven't heard of any organizations in Iraq supporting women's rights and they would like to see a change in that
