The position that I one day hope to have is that of the Chief Information Security Officer. This is not a position that is easily acquired, and it is normally a promotion that one gets later in their career. While it will be a long time before I have this position, it would be useful knowledge to know what is needed for proper consideration. This cooperation can largely benefit the organization and result in continually improving security posture ("What Is a CISO? Chief Information Security Officer").
