Relation to principle of science

Concepts

For example, the article quotes “Iraq has a very weak legislative system against cybercrimes, and there has been no considerable focus on the administrative regulations for the cybersecurity and protection of the organizations”(Pg 6, paragraph 1). This portrays denial of responsibility, where the Iraqi legislation denies the need for stronger cybercrime laws, leading towards cybercrime being more prevalent.

Challenges and concerns

There are three main contributions to the limitations of cyberlaw in Iraq according to participants in interviews.

1. Enforcement agencies lack resources, and training
2. Iraq's laws and regulations are outdated
3. No specifics in the cybercrime laws in Iraq cybercrime legislation

How does this relate to the challenges, and concerns of marginalized groups? The core theme is that due to lack of resources, funding and outdated laws, the people in Iraq who are considered lower in socio-economic status are negatively impacted by the limitations of the cyber laws.
