

## Review of Understanding Cybercrime

### Offending and Victimization Patterns from a Global Perspective

The article "Understanding Cybercrime Offending and Victimization Patterns from a Global Perspective" was written by Jin, Lee from George Mason University and published in the International Journal of Cybersecurity Intelligence and Cybercrime in 2022. The author analyzed three articles: Social construction of Internet fraud as innovation among youths in Nigeria, The relationship between parenting practices and cyberbullying perpetration: The mediating role of moral beliefs, and Cybersecurity risk in U.S. critical infrastructure: An analysis of publicly available U.S. government alerts and advisories. The author summarized the main point— understanding cybercrime offending and victimization patterns from a global perspective. Also, the author pointed out the unique properties of cybercrime behavior and the need to consider creative solutions to both cybercrime offending and victimization.

The author properly related the topics to the principles of the social sciences. This is a short concise article that comprises only three main paragraphs. However, the article includes all the information and uses the simplest explanations to let the audience understand. This is related to parsimony, which refers that scientists should keep their levels of explanation as simple as possible (Armistead, 2022). The author researched three different articles and summarized certain points. This is related to relativism, which means that all things are related (Armistead, 2022).

Throughout the article, the author summarized three different articles which had already been published. This is a typical archival research method. Also, the author stated that Jaeyong Choi, Seungmug Lee, and Layne Dittman were using a cross-sectional sample of South Korean adolescents ( $n = 779$ ), which related to experimental research. In Lanz's article, he extracted

information from 1,574 U.S. government alerts and advisories to generate insights into different research, this was a kind of survey research.

From all three articles mentioned by Lee, there are all quantitative data. Lee mentioned that the authors of all three articles analyze the collected data and extract the relationship between parenting practices and cyberbullying perpetration, the social construction of Internet fraud as innovation among youths in Nigeria, and an analysis of publicly available U.S. government alerts and advisories of cybersecurity risk in U.S. critical infrastructure.

At the beginning of Lee's statement, he stated that the research question was to seek to advance understanding of cybercrime offending and victimization patterns from a global perspective. Lee also hypothesized a recent surge in studies using international samples and multidisciplinary approaches to understand cybercrime patterns.

Archival research refers to the use of archives to conduct scientific endeavors. This concept is used in this article. Also, the author introduced the survey research method in Lanz's article. In Lee's article, he enumerates three different articles and summarizes the main concerns of the pattern of cybercrime offending and victimization patterns from a global perspective.

Overall, this article obtains a deeper understanding of social phenomena and produces the pattern of cybercrime offending and victimization patterns from a global perspective. Also, the author mentions that from an international perspective and seeks solutions that cover the wide breadth and scope of cybercrime and considers global perspectives in the fight against cybercrime.
