COURSE DESCRIPTION & PURPOSE: Study of the ethical and lawful issues and considerations that arise in oral healthcare professions. There will be a focus on risk management, ethics, morals, professionalism, and dental law. The purpose of this course is to prepare and educate dental hygiene students for ethical dilemmas and lawful decisions that may arise during their career.

METHODS OF EVALUATION: Throughout the semester, students will be assessed for achievement of course goals and objectives by a variety of methods including tests, group and individual projects and assignments, homework, oral presentation, written work, tests, and an exam. Some of these will be graded and some will not be graded. Regardless, completion of all is expected. A list of graded requirements is below:

2.	<u>Case Project & Presentation</u> - Develop an appropriate treatment plan for a complex patient case according to course criteria and orally present it to the class. This will be a collaborative group activity.
3.	Four (4) homework assignments
4.	Three (3) tests -Each will be multiple-choice
5.	Final Examination (comprehensive)

TESTING PROTOCOL: Tests may cover lecture materials, assigned readings, PowerPoints, and handouts. The final exam will be comprehensive. Tests and exams will be administered using Canvas Respondus Lockdown Browser and recorded by Zoom proctoring (cell phone with a camera) to ensure testing integrity.

 <u>Hardware Requirements</u>: Desktop computer or fully charged laptop, a webcam, a microphone (built-in or external), and a fully charged smartphone (iPhone or Android) with camera. NOTE: tablets and Chromebooks are <u>not</u> compatible with some Canvas testing options. You will also need a reliable internet connection (preferably a wired connection). • <u>Software Requirements</u>: Chrome, Firefox, Edge, or Safari. You will also need to download the Zoom application for Windows or Mac. Make sure to update your Zoom application.

How to take tests: 1) Put your smartphone in airplane mode. 2) On the day of a test and during our regularly scheduled class period, log into Canvas with your smartphone and click on the zoom session link for that day. 3) Enable your camera and adjust it so that I can see you. 4) Use your desktop/laptop computer to log into Canvas and access the "Tests & Exam" tab. 5) Within that tab, you will open the appropriate test/exam once I verbally announce that it is time to begin.

Tests are not released. For questions regarding tests, please make a Zoom appointment. **Tests may only be reviewed until the next test date.** Grades will not be changed for student errors on tests. ATTENDANCE POLICY: Attendance to each scheduled session is required. All students are expected to arrive on time to the class. In the case of an emergency, a student's absence may be excused. The student is to report the absence as soon as possible to the instructor. There must be written documentation to support the absence such as a doctor's note. An absence is considered excused if the student has provided adequate information and documentation. An unexcused absence will result in a penalty towards your final grade in the class. For each unexcused absence, there will be a 1 point deduction from your final grade.

MISSED TESTS & EXAMS: If a test or exam is missed, the student must complete the test/exam within 2 days, or by the next session. Past the 2 day period, the student will not be able to make up the test/exam, resulting in a grade of 0. The student must meet with the instructor to schedule a time to make up the missed test/exam prior to the deadline. Tests and exams missed due to an unexcused absence will result in a grade of 0.

SUBMITTING ASSIGNMENTS: Assignments must be submitted on time, by the due date. Assignments are to be submitted by Sunday at 11:59pm or at another specified time. Assignments are to be submitted in either Microsoft Word or Microsoft Powerpoint. School of Dental Hygiene Policy on Professionalism in the Use of Social Media:

The Internet has created the ability for dental hygiene students and oral health professionals (dental hygienists and dentists) to communicate and share information quickly to reach millions of people easily. Participating in social networking and other similar Internet opportunities can support students' and dental hygienists' personal expression, enable individuals to have a professional presence online, foster collegiality and camaraderie within the profession, provide opportunity to disseminate public health and other health messages. Social networks, blogs, and other forms of communication online also create new challenges to the patient-oral health provider relationship. Oral health professionals and students must weigh a number of considerations when maintaining a presence online.

- (a) Standards of patient and colleague privacy and confidentiality must be maintained in all environments, including online, and oral health professionals and students must refrain from posting identifiable person information online.
- (b) When using the Internet for social networking, oral health professionals and students must use privacy settings to safeguard personal information and content to the extent possible, but realize that privacy settings are not absolute and that once on the Internet, content is likely there permanently. Thus, oral health professionals and students should routinely monitor their own Internet presence to ensure that the personal and professional information on their own sites and, to the extent possible, content posted about them by others, is accurate and appropriate.
- (c) If interacting with patients on the Internet, oral health professionals and students must maintain appropriate boundaries of the patient-oral health provider relationship in accordance with professional ethical guidelines just as they would in any other context.
- (d) To maintain appropriate professional boundaries oral health professionals and students should consider separating personal and professional content online.
- (e) When oral health professionals or students see content posted by colleagues that appear unprofessional or a violation of the Code of Ethics of the American Dental Hygienists' Association, they have a responsibility to bring that content to the attention of the individual, so that he or she can remove it and/or take other appropriate actions. If the behavior significantly violates professional norms and the individual does not take appropriate action to resolve the situation, the dental hygienist and or students should report the matter to appropriate authorities, e.g., the State Board of Dentistry, the University Honor Council.
- (f) Oral health professionals and students must recognize that actions online and content posted may negatively affect their reputations among patients, colleagues, employers and potential employers and may have consequences for their careers now and in the future, and can undermine public trust in the dental hygiene profession.

- e. Adhere to the ethical code for dental hygienists.

- b. Organize the six steps provided in the ethical decision-making model.
- c. Discuss the categories of common ethical dilemmas for dental hygienists.
- d. Apply the decision-making model to a hypothetical situation.
- e. Advocate for ethical decision making in the dental practice.

- e. Avoid malpractice and negligence behaviors.
- 10. Chapter 10; "Dental Hygienist-Dentist-Employer Relationship":
 - a. Identify the recommended strategies for preparing for a dental hygienist employment interview.
 - b. Create an interview questionnaire for a dental hygienist position.
 - c. Describe the federal laws prohibiting discrimination and protecting worker safety.
 - d. Detect sexual harassment and a hostile work environment in the dental practice setting.
 - e. Avoid inappropriate interview questions.
