Multiple studies have found that climate change has already led to an increase in wildfire season length, wildfire frequency, and burned area. 2.3 The wildfire season has lengthened in many areas due to factors including warmer springs, longer summer dry seasons, and drier soils and vegetation. 2 Similarly, climate change threatens to increase the frequency, extent, and severity of fires through increased temperatures and drought (see the U.S. and Global Temperature and Drought indicators)."
