Standard 1 for educators outlines the responsibility for professional growth. Section 2.1 for educators, in the role of a learner, requires them to continue improving upon their practice by learning from others and exploring practices that use technology to further develop learning by students (ISTE, 2023).

Being a human services professional (HSP) and member of the National Organization for Human Services (NOHS) pledges my allegiance to a similar set of ethical standards. The obligation established by the ISTE for educators is similarly translated to the Responsibility to the Profession delegated to HSP's in Standard 26 where the National Organization for Human Services (2015) states:

Human service professionals seek the training, experience, education, and supervision necessary to ensure their effectiveness in working with culturally diverse individuals based on age, ethnicity, culture, race, ability, gender, language preference, religion, sexual orientation, socioeconomic status, nationality, or other historically

oppressed groups. In addition, they will strive to increase their competence in methods which are known to be the best fit for the population(s) with whom they work. (p.6)
