Introduction

Throughout my Cybersecurity program at Old Dominion University, I have learned various new skills that come from different disciplines such as technology, writing, ethics, policies, and real world critical thinking. Although my major is cybersecurity many of my courses have required me to think outside the box as Cybersecurity overlaps in many different fields. This IDS 493 course has brought all my coursework together to showcase my top skills and artifacts that demonstrate my growth and has allowed me to reflect on how these academic cases and workplace experiences have prepared me for my career. After reviewing all my content, I have chosen three that best represent my strengths. These skills I have chosen are Data Processing and Analysis, Technical Writing and Communication, and Project Management and Leadership. These skills created the foundation through a mix of my cybersecurity course, electives, and my full time work experience at Preferred Direct Marketing, a commercial printer and marketing firm. As my career path grows into my anticipated path of GRC Analysis we can see how these experiences are shaped and ultimately tie together.

Skill 1 - Data Processing and Analysis

Data Processing and Analysis has become one of my strongest skills thanks in part to my full time job. My job requires me to examine and process sensitive data, also known as PHI. During my internship course CYSE 368 I chose my job as it aligned with my field and allowed me to look at my work from a different lens. My first artifact is my final internship report as in this report I describe the tools I use at work such as BCC Mail Manager, and Postal One. These are processed and merged using HIPAA and HITRUST rules to ensure the CIA triad, Confidentiality, Integrity, Availability.

My second artifact is an example of data merge which is also a part of my job. This means once receiving the data from the client I must process and then merge data from our graphics department and form the design and formats for our production team. Some of these fixes maybe be fixing addresses, adjusting the printing format for production, or even ordering the files in correct order. When it comes to commercial printing accuracy is one of the most important things you can do or else the whole order and resources have gone to waste. For this process clear communication between the different departments must be established. I learned how to verify the data, follow the procedures, and prevent mistakes that could impact millions of mailing content.

For my third artifact I have chosen one of my papers from CYSE 425W. This paper corresponds with my current job and internship course as the content topic is HIPAA and the various implications it effects from social, policy, and technology growth. This artifact shows the ability to critically think and examine how policies effect and change business and organization operations. It's important that we understand why policies are implemented and what they can do in the short and long term.

Skill 2 – Technical Writing and Communication

Technical writing and communication became another important skill to my degree and internship. Cybersecurity requires clear writing because any mistakes and misunderstanding can create potential risks and cause delays in problem solving. For my first artifact in this skillset, I have chosen my paper from ENG 211C course as this paper talks about the growth and shape of identity. This assignment required me to combine policy, ethics, technology, and society to analyze the growing issues of surveillance. Writing this helped me piece together understanding that cybersecurity is much more complex than what the general person may believe. This matters because during technical risks cases you maybe need to understand the background context that might not even have anything to do with cybersecurity. This may also come in handy when talking to others who are not specialized in the cybersecurity, but the problem corresponds the field.

My third artifact is different journal from my CYSE 368 course. While taking this course the journals required a different topic and how that relates to my job. I believe these journals overall how I can document my experiences and what my take aways are from the workday.
